

Designer Bonus Registration Form

Contestants intending to claim the own design bonus points, must register their intention on this form with the IJMC Board for ratification, at least two months before the competition. This is only applicable for the "one off own design" (50 points) and the "own design developed into a kit" (30 points). For the contestant with a traditional kit with foam or built-up wings, photographs from the building stages presented together with the contestants's declaration sheet suffice. The designer bonus is intended to honour a single contestant or two contestants (*) who have done the major work themselves to create their own model: in other words, at least 50% of the design, development and building of the model. It is NOT intended for contestants who pretend it is their own design or who have instructed or commissioned anyone else to create the model! The IJMC Board will decide if the claim is valid or not. No protest against this decision can be made.

(*) In the case of two contestants claiming the designer bonus, only one form must be submitted but the two names must be filled in. The bonus points are **shared** between the two.

The file supporting the designer bonus claim must at least contain the following:

- **Gathering of information:** describe where you sourced drawings, photographs and other documentation material (i.e. from museum, from publications, from internet or from any other source).
- **Design drawings:** describe your workmethod of making the drawings for constructing the model (i.e. did you make manual drawings or did you use CAD software, which CAD software etc.).



- Build of the model: describe your workmethod of building the model (i.e. wood construction or composite construction or a mixture of both, creation of master, of moulds, of final model etc.). Describe which tools were used. Support all this with photographic evidence.
- Help from others: describe what percentage of the work was done yourself and what percentage of the work was done by others. List the names of all the persons/companies who helped in developing the model or components of the model and mention their share of the work done.
- Development into a kit: describe to what extent the model is (or will be)
 developed into a kit available to other modelers. Describe what the share
 of the actual or future manufacturer is in the design and the development
 of the model.
- **Funding:** describe how you fund the design of the model (i.e. own funding, support from a (future) manufacturer or sponsoring etc.). List the name of the persons/companies who sponsor the project.
- Use of commercial components: list all the commercially available components used to build the model, i.e. landing gear or parts of landing gear, wheels, tyres, brakes, air cylinders, pneumatic components, hinges, control linkages etc. Exceptions: no need to list the radio equipment nor the propulsion system.

Remark: all the information submitted remains strictly confidential and will not be divulged by the IJMC Board to the public.

Send this registration form together with your file supporting this claim to the IJMC Chairman at the address shown on the www.ijmc.net website at least two months prior to the start of the competition.
